



## WAIVER AND RELEASE

**Participant Assumes Risks.** By signing this Waiver and Release, we fully understand and acknowledge the following statements and declare that we and our minor children assume any risks relating to participation in the Community Bicycle Ride sponsored by Lawrence Central Rotary (the “event”).

- Cycling requires proper physical and medical condition, training, and safe and working equipment.
- Cycling can expose riders to serious hazards, including other cyclists and vehicles.
- Cycling can result in accidents, illness, serious injury, and damage to property.
- Treatment for any accident, illness, or injury might incur large medical bills for which we are solely responsible.

In consideration for participating in the event, and intending to be legally bound, we hereby voluntarily agree as follows:

1. **Release of Claims against Rotary.** We irrevocably release and discharge the premises owner, the event’s sponsors, including Rotary International and Lawrence Central Rotary Club, and the foregoing parties’ affiliates, agents, and employees (collectively, “Rotary”) from all claims arising under or relating to the premises, the event, and the photography and emergency assistance contemplated by this Waiver and Release, whether direct or indirect, including any accident, injury, illness, damage to property, libel, or violation of any rights of publicity or privacy (the “Released Claims”) for ourselves and our minor children. We and our minor children shall not, directly or indirectly, assert any claim or lawsuit against Rotary relating to the Released Claims. We and our minor children shall reimburse, indemnify, and hold harmless Rotary for all losses and expenses it may suffer (including lawyers’ fees and expenses) relating to the Released Claims. This Waiver and Release does not constitute an admission of liability by Rotary and any such liability is hereby expressly denied.
2. **Rotary May Use Photographs.** We irrevocably grant permission to Rotary to obtain, use, and publish our and our minor children’s names, images, photographs, video and audio recordings, and likenesses, whether in whole or in part, individually or in connection with other material, in any media for publicity and other Rotary purposes.
3. **Consent to Emergency Assistance.** We and our minor children consent to receive, but shall not exclusively rely upon, assistance from Rotary or others in the event of an emergency, including transportation to another location, and shall pay all costs associated with such emergency assistance.

We have carefully read this Waiver and Release and fully understand its contents. By our signatures below, we and our minor children voluntarily consent and agree to the terms of this Waiver and Release.
